DIRECTIONS TO TRIAL SITE — SOLANO COUNTY FAIRGROUNDS, Vallejo, CA.

- Take Interstate 80 either west or east to Vallejo.
- Take the Highway 37 exit, then take the first exit (Fairgrounds and Marine World).
- Proceed south for two blocks and turn left into the main entrance parking lot of the fairgrounds.

PARKING -- All vehicles must enter through the Main Gate parking lot. There may be a parking fee of \$5.00. Go straight through the main parking lot. If no other event is being held at the Fairgrounds, then drive through the gate. Turn left in front of the Exhibition Hall, then turn right at the corner. Continue past the off-track betting building and McCormack Hall is on your left. Parking is available both in front and behind McCormack Hall.

McCORMACK HALL SPACE LIMITATIONS — Due to the fact that this is an indoor trial, please help us make it comfortable for all exhibitors by being "space" conservative. Please reserve x-pen use for multiple dogs. Thank you for your cooperation and for attending.

PLEASE DO NOT SET UP ON LAWN AREAS!!! — The Club does not have any of the lawn areas rented for the trial. The lawns are considered separate rental spots. If you are set up on one of the lawns, the Fairgrounds personnel may ask you to move.

OBEDIENCE AND RALLY MOVE-UPS are allowed for dogs completing a title after close of entries, PROVIDED SPACE IS AVAILABLE IN THE CLASS. The request must be made IN WRITING at least 30 minutes prior to judging. Please inform the Trial Secretary as soon as possible if you wish to move your dog to the next level class. Move-ups will run at the end of the class (or with their rally jump height if possible).
