Additional Trial rules

The club is not responsible for the loss or damage to any dogs entered whether by accident or other cause. Dogs are in the custody of their owner or agent.

Dogs must be kept on leash except when in the ring.

DOGS MUST BE READY FOR JUDGING. The club is not obligated to notify exhibitors of the start of judging. Owners or agents are responsible for the presence of their dogs in the ring.

DOGS NEED ONLY be present at the scheduled time of judging and will be excused when no longer needed for further judging. **DO NOT LEAVE DOGS UNATTENDED IN VEHICLES.**

IN ORDER TO PREVENT loss of the facility for future events, Vallejo Dog Training Club asks that participants adhere to facility rules. All dogs present must be held on leash or confined to their crates except when judged.

IT IS EACH PARTICIPANT'S RESPONSIBILITY to clean up after his or her dogs and clean up his or her area after the show. **NO EXCEPTIONS.**

No provisions are made for un-entered dogs. No un-entered dogs will be allowed within the Trial limits defined as the Mt. Diablo Training building

All persons attending this show hereby waive any claim for damages against the Vallejo Dog Training Club, its members, event secretary or landlord in the event a motor vehicle has to be entered to rescue a dog from overheating.

- 1) We ask that you do not attend the trial if you feel sick. (If the club is able to fill your entries from the wait list, your entry fees will be refunded)
- 2) Do not attend the trial if you have traveled out of state and have not sheltered in place for 14 days!
- 3) Do not attend the trial if you have been to any large gatherings within the 14 days prior to this trial!
- 4) All participants will be required to follow state, local and the facility guidelines that are in effect at the time of the trial.
- 5) All participants are required to wear a mask while at the premises. You must bring your own mask!

Notice to Exhibitors

FEES: An AKC event service fee of \$3.00 per entry and an AKC recording fee of \$0.50 per dog will be required for each dog entered at any Licensed or Member Obedience Trial or Rally Trial.

Entry fees will not be refunded in the event of errors or cancellations of entries after the published closing date, nor in the event that a dog is absent, disqualified, sick, lame, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.

If, because of riots, civil disturbances, loss of site, pandemics or other act beyond the control of the management it is impossible to open or complete the trial no refund of entry fees will be made.

Extreme weather conditions such as, but not limited to hurricanes, fire, lightening, extreme heat or earthquake, must be considered for the health and safety of the dogs, exhibitors and spectators. The wellbeing of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fees will be made.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable disease and have appropriate vaccinations.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
